HIP ARTHROPLASTY: HOW TO AVOID DEFICITS AFTER THA

- Spinal instrumentation and impact on hip dislocation
 - THA patients with fixed spinopelvic alignment from standing to sitting at higher risk
 - Lumbar fusion involving the sacrum increases dislocation risk 8-fold
- Effects of piriformis tendon repair failure
- Electromyographic analysis implications
 - Effects on gluteus medius and gluteus maximus
- Restriction for return to sport






