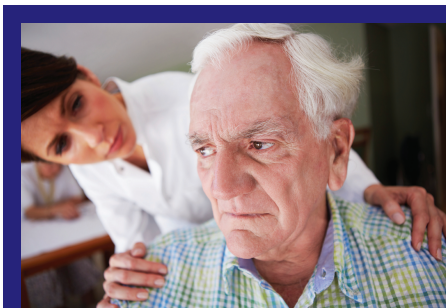

Previously she has worked as a nurse practitioner, director and staff nurse across various settings as she has focused in on her specialty of geriatric/dementia care. Nanette shared her knowledge with others as a clinical assistant professor at East Carolina University College of Nursing, a clinical instructor at UNCG and an adjunct faculty member at Vanderbilt University School of Nursing.

Nanette has presented nationally and internationally on dementia, pain management, caregiver issues, and topics specific to long-term care. She is the author of *Eldercare: The Comprehensive Guide to Caregiving* and a new evidence-based clinical practice guideline for the non-pharmacological management of behavioral problems in dementia. 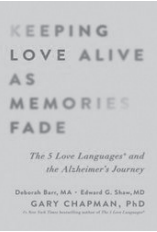

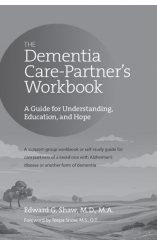
